Bid Security in the amount of five percent (5%) of the Proposal, including all add alternates must accompany each Proposal in accordance with the Instructions to Bidders.

The project is exempt from Indiana Sales tax. An exemption certificate will be provided to the successful bidder.

The project is subject to a Davis-Bacon Wage Scale, as listed in the Specifications.

The Owner reserves the right to accept or reject any bid and to waive any irregularities in bidding.

The Base Bid may be held for a period not to exceed Forty-Five (45) days before awarding Contracts.

All additive Alternate Bids may be held for a period not to exceed Sixty (60) days after signing of Contract.

Should a successful Bidder withdraw their bid, or fail to execute a satisfactory contract within ten (10) days after notice of acceptance of his bid, the Owner may declare the Bid Security forfeited as liquidated damages, not as penalty.

The successful Bidder shall furnish a Performance Bond and Labor and Materials Payment Bond in an amount equal to one hundred percent (100%) of the Contract Sum with an approved surety company and said bond shall remain in full force and effect for a period of one (1) year after date of final acceptance of the work. The cost of all bonds shall be included in the bid price.

Documentation will be required to comply with the conditions of the FEMA grant.
